Klanje živine i proizvodnja (sečenje i pakovanje) svežeg i zamrznutog pilećeg mesa sa i bez začina, dimljeno ili ne, pakovanog u MAP, vakuum, na PS i PP podloške i PE kese. Sečenje, mešanje, pasteurizacija i punjenje kobasica u PA, celulozne i kolagenske omotače. Sečenje, salamurenje, dimljenje i pasteurizacija dimljenih proizvoda od mesa pakovanih u PE foliju sa vakuumom. Sečenje i mariniranje pripremljenih sirovih jela (meso sa povrćem) pakovanih u PP podloške u MAP-u. Kompanija ima sopstvene brokerske aktivnosti koje nisu sertifikovane prema zahtevima IFS Broker i drugih GFSI priznatih standarda. The company has own broker activities which are not IFS Broker and other GFSI recognized standard certified. Besides own production, the company has partly outsourced processes.
